**PRICE CONTROL ACT
(CAP. 64)****PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION
OF PRICES) (AMENDMENT) (NO.15) ORDER 2017**

I, **Hon. Elijah Doro Muala**, Minister for Commerce, Industries, Labour and Immigration, under section 6 of the *Price Control Act* (Cap. 64), make the following order.

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No.15) Order 2017, and commences on 1 May 2017.
2. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice 47 of 1987) is amended in Schedule 3 by deleting serial no. 13 (Petroleum Products) and substituting the following:

“13. PETROLEUM PRODUCTS

Wholesale (Maximum price in cents per litre)	Retail (Maximum price in cents per litre unless otherwise specified)

PETROLEUM PRODUCTS

(a) Petroleum motor spirit (PMS)	627.84	807.0
(b) Distillate (ADO)	614.34	791.5
(c) Kerosene (KERO)	577.22	(Maximum percentage mark-up)

- cost into store plus 15% for sales of packaged product
- cost into store plus 20% for break bulk sales”
