**CUSTOMS AND EXCISE ACT  
(CAP. 121)****CUSTOMS AND EXCISE (IMPORT DUTIES) (AMENDMENT)  
(NO.3) ORDER 2018**

I, Hon. **Manasseh Damukana Sogavare**, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:

**Citation and Commencement**

1. This Order may be cited as the Customs and Excise (Import Duties) (Amendment) Order 2018 and commences on 1 October 2018.

**Amendment to the First Schedule**

2. The First Schedule to the *Customs and Excise Act* (Cap. 121), as replaced by Legal Notice No. 66 of 2018 is amended in tariff items 22.03 to 22.08 by deleting all items from 2203.0010 to 2208.9040 (inclusive) and substituting the following:
