EMERGENCY POWERS ACT (CAP. 11)

EMERGENCY POWERS (COVID-19)(No. 3) REGULATIONS 2020

EMERGENCY POWERS (COVID-19)(EXTENSION OF QUARANTINE)(NO. 4) ORDER 2020

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 22A of *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), being satisfied that it is necessary to do so to prevent the transmission of COVID-19 within Solomon Islands, make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Extension of Quarantine)(No. 4) Order 2020.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Definition

In this Order:

"extended quarantine period" means the period for which a quarantine period is extended under paragraph 4.

4 Extension of quarantine

The quarantine period of each person specified in the Schedule (who are persons who entered Solomon Islands on 29 September) is extended for 21 more days ending on 20 November 2020, and each of those persons must be quarantined at a quarantine station during that 21-day period.

5 Testing of persons whose quarantine extended under paragraph 4

Each person whose quarantine period is extended under paragraph 4 must be tested for the presence of COVID-19:

- (a) on the second day of the extended quarantine period; and
- (b) on a day between the fifth day and the tenth day of the extended quarantine period; and
- (c) on a day between the twelfth day and the fourteenth day of the extended quarantine period; and
- (d) on a day between the nineteenth day and twenty-first day of the extended period.
- (2) Each of those persons must test negative for COVID-19 for each of the 4 tests
