**EMERGENCY POWERS (COVID-19) REGULATIONS 2021****EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 94) ORDER 2021**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

**1 Citation**

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 94) Order 2021*.

**2 Commencement**

This Order commences on the day it is published in the *Gazette*.

**3 Non-citizens who may enter Solomon Islands**

Each person specified in the Schedule may enter Solomon Islands despite the prohibition under regulation 7(1) of the Regulations.

**4 Expiry**

This Order expires on 18 October 2021.
