1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 158) Order 2021.*

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-citizens who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* on 13 September 2021 despite the prohibition under regulation 7(1) of the Regulations.

4 Amendment of Legal Notice 242 of 2021

The Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 157) Order 2021 (Legal Notice 242 of 2021) is amended:

- (a) by omitting paragraph 3(2); and
- (b) by omitting Schedule 2.

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 69) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice 198 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 69) Order 2021.*

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from quarantine period

- (1) Each person specified in the Schedule is exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 13 September 2021.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Pacific Casino Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported to the Pacific Casino Hotel from Honiara International Airport, and from the Hotel to the Airport, in accordance with the Government's quarantine procedures.

4 Amendment of Legal Notice 243 of 2021

The Emergency Powers (COVID-19) (Exemption from Quarantine Period) (No. 68) Order 2021 (Legal Notice 243 of 2021) is amended:

- (a) by omitting paragraph 3(2); and
- (b) by omitting from paragraph 3(3) "exemptions under subparagraphs (1) and (2) are" and substituting "exemption under subparagraph (1) is"; and
- (c) by omitting Schedule 2.
