**POLICE ACT 2013**

(No. 2 of 2013)

**POLICE (AMENDMENT) REGULATIONS 2025**

I, Hon. Jimson Fiau Tanangada, Minister for Police, National Security and Correctional Services, under section 218 of the *Police Act 2013* and with reference to section 36 of the *Interpretation and General Provisions Act* (Cap. 85), make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Police (Amendment) Regulations 2025*.

**2 Commencement**

These Regulations commence on the date they are published in the Gazette.

**3 Amendment of Police Regulations 2013**

These Regulations amend the *Police Regulations 2013* (Legal Notice No. 18 of 2014) (“*Principal Regulations*”).

**4 Schedule 2 amended**

Schedule 2 to the *Principal Regulations* is amended by inserting the following after item “Police Maritime Division Officers Special Duty” in the table under heading “A. Special Allowance”:

<b>“Special deployment allowances</b>	<b>Tier 1</b>	\$1,500 per fortnight for police officers deployed on special security operations during major national, regional or international events within Solomon Islands as authorised by the Commissioner
	<b>Tier 2</b>	\$1,800 per fortnight for police officers deployed in high-risk security operations to manage threats to private companies, firms or investments operating within Solomon Islands as authorised by the Commissioner.

<b>Tier 3</b>	\$150 per day for officers who carry out duties in a declared operational area at the Solomon Islands international maritime border as authorised by a Commissioner’s Order.”
