**PROVINCIAL GOVERNMENT ACT 1997  
(No. 7 of 1997)**

**GUADALCANAL PROVINCE BUSINESS AND HAWKERS LICENSING  
(AMENDMENT) ORDINANCE 2025**

In exercise of the powers under section 30 of the *Provincial Government Act 1997*, the Guadalcanal Provincial Assembly, makes the following Ordinance:

**1 Citation**

This Ordinance may be cited as the *Guadalcanal Province Business and Hawkers Licensing (Amendment) Ordinance 2025*.

**2 Commencement**

This Ordinance commences on the date this Ordinance is published in the Gazette.

**3 Principal Ordinance amended**

This Ordinance amends the *Guadalcanal Province Business and Hawkers Licensing Ordinance 1985* (“**Principal Ordinance**”).

**4 Schedule 1 amended**

- (1) Item No. 7. MINING & EARTH MOVING INDUSTRIES, under Schedule 1 of the Principal Ordinance is amended by:
- (a) deleting “Actual Mining license \$500,000.00” and substituting “Mining License \$5,000 000.00”; and
  - (b) deleting “Prospecting License (per sites) fee of \$50,000.00” and substituting “Prospecting License \$250,000.00”; and
  - (c) deleting “Gold Dealing License \$5,000.00” and substituting “Gold Dealer License \$10,000.00”; and
  - (d) deleting “Actual Mining Lease Alluvial \$75,000.00” and substituting

“Alluvial Mining \$2,000,000.00”.

- (2) Item No. 12. LIGHT INDUSTRIES, under Schedule 1 of the Principal Ordinance is amended by deleting “Quarrying \$3,000.00” and substituting “Quarrying \$20,000.00”.
