IMMIGRATION ACT 2012

(No. 3 of 2012)

NOTICE OF CONCESSIONAL ENTRY ARRANGEMENT COUNTRIES

I, Jaimie Lency Vokia, Minister for Commerce, Industry, Labour and Immigration, under section 3 of the *Immigration Act 2012* (“the Act”), and with reference to section 36 of the *Interpretation and General Provisions Act* (Cap. 85):

- (a) specify that each country listed in the Schedule is a concessional entry arrangement country for the purposes of the Act; and
- (b) repeal the following:
 - (i) Revocation of Concessional Entry Arrangement Country (Legal Notice No. 113 of 2025);
 - (ii) Concessional Entry Arrangement Country (Legal Notice No. 110 of 2024);
 - (iii) Concessional Entry Arrangement Countries (Legal Notice No. 10 of 2017).
