CUSTOMS DUTY (AMENDMENT) (NO. 2) ORDER 2013

CUSTOMS ACT 2007

IN EXERCISE of the powers conferred by section 3 of the Customs Act 2007, the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order -

1 Short title

- (1) This Order may be cited as the Customs Duty (Amendment) (No. 2) Order 2013.
- (2) The Customs Duty Order 2008 imposing excise tax on goods effective from 1 February 2008 and published in the Tonga Government Gazette Supplement Extraordinary on 21 January 2008, as amended, shall be referred to as the Principal Order.

2 Principal Order amended

The Principal Order is amended by –
