CUSTOMS DUTY (AMENDMENT) ORDER 2018

CUSTOMS ACT 2007

IN EXERCISE of the powers conferred by section 3 of the Customs Act 2007, the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order -

Commencement [Date]

- (1) This Order may be cited as the Customs Duty (Amendment) Order 2018.
- (2) The Customs Duty Order 2008, as amended, imposing customs duty on goods effective from 1 February 2008 and published in the Government Gazette Supplement Extraordinary on 21 January 2008 shall be referred to as the Principal Order.
- (3) The commencement date of this Order shall be the 9th day of July 2018.
