CIVIL AVIATION (LICENSING CHARGES) (AMENDMENT) REGULATIONS 2012

CIVIL AVIATION 1990

IN EXERCISE of the powers conferred by section 7 of the Civil Aviation Act 1990, the Minister of Transport, with the consent of Cabinet, makes the following Regulations-

1 Short Title

- (1) These Regulations may be cited as the Civil Aviations (Licensing Charges) (Amendment) Regulations 2012.
- (2) The Civil Aviation (Licensing Charges) Regulations 1996, as amended are in these Regulations referred to as the Principal Regulations.

2 Paragraph 14 of the Schedule amended

Paragraph 14 of the Schedule of the Principal Regulations is amended by deleting the amount “\$250.00” and “\$75.00” and replacing them with the amount “\$430.00” and “\$130.00”.

3 Paragraph 15 of the Schedule amended

Paragraph 15 of the Schedule of the Principal Regulations is amended by deleting the amount “\$300.00” and replacing with “\$540.00”.

4 Paragraph 16 of the Schedule amended

Paragraph 16 of the Schedule of the Principal Regulations is amended by deleting the words “to be charged” and replacing with the word “payable” and by deleting the words “the discretion of the Minister and shall be based upon, but shall not exceed, the cost of the engineering investigation into the design and construction of the aircraft components for the purposes of the certificate” and replacing with “all related costs”

5 Paragraph 17 of the Schedule amended

Paragraph 17 of the Schedule of the Principal Regulations is amended by deleting the amount —

- (a) “\$650.00” and replacing with “\$800.00”,
- (b) “\$350.00” and replacing with “\$600.00”; and
- (c) “\$200.00” and replacing with “\$400.00”.

6 Paragraph 18 of the Schedule amended

Paragraph 18 of the Schedule of the Principal Regulations is amended —

18A.A by deleting the amount “\$250.00” and replacing with “\$375.00”;

- (a) by deleting the amount “\$350.00” and replacing with “\$500.00”;
- (b) by deleting the amount “\$175.00” and replacing with “\$400.00”;
- (c) by deleting the amount “\$75.00” and replacing with “\$300.00”.

7 Paragraph 19 of the Schedule amended

Paragraph 19 of the Schedule of the Principal Regulations is amended by deleting the amounts “\$100.00” and replacing with “\$300.00” and by inserting the words “or renewal” after the word “issue” in the first line.

8 Paragraph 20 of the Schedule amended

Paragraph 20 of the Schedule of the Principal Regulations is amended by inserting the word “or renewal” in the first line and by deleting the amount “\$750.00” and replacing with “\$1200.00”.

9 Paragraph 21 of the Schedule amended

Paragraph 21 of the Schedule of the Principal Regulations is amended by deleting the amount “\$1000.00” and replacing with “\$1,250.00” and by inserting the words “or renewal” after the word “issue”.

10 Paragraph 22 of the Schedule amended

Paragraph 22 of the Schedule of the Principal Regulations is amended by deleting the amount “\$150.00” and replacing with “\$350.00”.

11 Paragraph 23 of the Schedule amended

Paragraph 23 of the Schedule of the Principal Regulations is amended by deleting the amount “\$50” and replacing with “\$80.00”.

12 New Paragraph in Schedule

The Principal Regulations is amended by inserting the following new Paragraphs after Paragraph 25 of the Schedule:

“26 Foreign Air Transport Operator Certificate

A fee of \$1250 shall be payable for the issue or renewal of the Foreign Air Transport Certificate.

27 Aerodrome Operating Certificate

A fee of \$1250 shall be payable for the issue or renewal of an Aerodrome Operating certificate.

28 Aviation Security Service Certificate

A fee of \$1250 shall be payable for the issue or renewal of an Aviation Security Service Certificate.

29 Aeronautical Telecommunication Service Certificate

A fee of \$1250 shall be payable for the issue or renewal of an Aeronautical Telecommunication Service Certificate.

30 Air Traffic Service Certificate

A fee of \$2180 shall be payable for the issue or renewal of an Air Traffic Service Certificate.

31 Instrument Flight Procedure Service Certificate

A fee of \$1250 shall be payable for the issue or renewal of an Instrument Flight Procedure Service Certificate.

32 Meteorological Service Certificate

A fee of \$1250 shall be payable for the issue or renewal of the Meteorological Service Certificate.

- 33 Aeronautical Information Service Certificate**
A fee of \$1250 shall be payable for the issue or renewal of an Aeronautical Information Service Certificate.
- 34 Regulated Air Cargo Agent Certificate**
A fee of \$1250 shall be payable for the issue or renewal of a Regulated Air Cargo Agent Certificate.
- 35 Ground Handling Operator Certificate**
A fee of \$1250 shall be payable for the issue or renewal of a Ground Handling Operator Certificate.
- 36 Air Traffic Controller Licence**
A fee of \$375 shall be payable for the issuance and renewal of Air Traffic Controller Licence.
- 37 Regulatory service Hourly/Daily rate**
An hourly rate of \$100 or daily rate of \$1000 shall be payable for all regulatory services provided by the Ministry.
- 38 Penalty fee**
A penalty fee of 5% of unpaid accounts shall be payable for any unpaid account within the set timeframe.
- 39 Miscellaneous**
A fee of up to \$100 may be payable for any miscellaneous activities.”
