### TRAFFIC (AMENDMENT) REGULATIONS 2011

#### **TRAFFIC ACT (CAP 156)**

IN EXERCISE of the powers conferred by section 40 of the Traffic Act (Cap. 156), the Principal Licensing Authority, with the consent of Cabinet, makes the following Regulations -

#### 1 Short Title

- (1) These Regulations may be cited as the Traffic (Amendment) Regulations 2011
- (2) The Traffic Regulations, as amended, are in these Regulations referred to as the Principal Regulations.

#### 2 Fourth Schedule – Amended

- (1) The Fourth Schedule of the Principal Regulations is amended:
  - (a) by repealing Part B and replacing it with the following –
