## NOTICE

### PASSPORT ACT (CAP. 61)

(Section 32 (4))

HIS MAJESTY in Council pursuant to Section 32 (4) of the Passport Act (Cap. 61) as amended, PRESCRIBES the following amendments to the Notice appearing in the Tonga Government Gazette Supplement Extraordinary No. 1 of 2 April 1992 :

1. Paragraph 6 is renumbered as paragraph 7.
2. The following is inserted as paragraph 6 :  
  
"6. A Tongan Protected Person's Passport may be replaced by a Tonga National Passport and the fee for such a Tonga National Passport shall be the difference between the fee prescribed for the Tonga Protected Person's Passport and the fee prescribed for the Tonga National Passport."
