WATER BOARD ACT

(Section 28)

WATER SUPPLY (AMENDMENT) REGULATIONS 1992

In exercise of the powers conferred by section 28 of the Water Board Act (Cap. 92), His Majesty in Council makes the following Regulations:-

- 1. (1) These Regulations may be cited as the Water Supply (Amendment) Regulations 1992.
- (2) The Water Supply Regulations are in these Regulations referred to as the Principal Regulations.
- 2. Regulation 18(3) of the Principal Regulations is amended by deleting "\$20" and "\$10" and substituted by "\$500" and "\$50" respectively.
- 3. Regulation 19(1) of the Principal Regulations is amended by deleting "of \$20" and substituted by the following -

"not exceeding \$500, and in the case of a continuing offence, a further fine not exceeding \$50".

- 4. Regulation 26(3) of the Principal Regulations is amended by deleting "\$100" and substituted by "\$1000".
- 5. Regulation 29 of the Principal Regulations is amended by deleting "\$10" and "\$1" and substituted by "\$500" and "\$50" respectively.

LICENCES ACT (Section 5(3))

- 2. The maximum number of licences that may be issued under the Licences Act, in respect of all the districts in the Kingdom, to export squash to Japan in 1992 shall be 7.
