## THE CUSTOMS AND EXCISE ACT

(Chapter 67)

### ORDER IN COUNCIL

In exercise of the powers conferred by Section 19(b) of the Act of the Constitution of Tonga the Treasurer, with the approval of Privy Council hereby alters the rates specified in Part I of Schedule 1 of the Customs and Excise Act (Chapter 67) by replacing the rates of duty in that Part and Schedule by deleting the rates for the items specified in that Schedule and inserting in their stead the rates set out in Schedule hereto, and further orders and declares that this Order in Council shall have effect from the date of publication in the Gazette.
