CUSTOMS ACT 2007

(Section 3(1)(b))

ORDER

IN EXERCISE of the powers conferred by section 3(1)(b) of the Customs Act 2007, the Minister of Revenue and Customs, with the approval of Cabinet, makes the following Order:

That the spare parts, tools and equipment donated to the Kingdom by the People's Republic of China for the maintenance of the MA60 aircraft, as certified by the Ministry of Infrastructure, shall be exempted from customs duty.

CONSUMPTION TAX ACT 2003

(Section 5(3)(a))

ORDER

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister of Revenue and Customs, with the approval of Cabinet, makes the following Order:
