**WE, TUPOUVI, BY THE GRACE OF GOD, OF TONGA, KING:  
HAVING CONSIDERED Advice from the Lord Speaker of the Legislative  
Assembly, and**

**HAVING REGARD to Clauses 38 and 77(2) of The Act of Constitution  
of Tonga (Cap. 2) DO lawfully dissolve the Legislative Assembly with  
effect from Thursday 24 August 2017 at 1700 hours and DO Command that  
new Representatives of the Nobles and People be elected to enter the  
Legislative Assembly at Elections to be held no later than 16 November  
2017.**

**DONE by Us at Nuku' alofa, this Twenty Fourth day of August in the Year  
of Our Lord Two Thousand and Seventeen and in this the Sixth Year of  
Our Reign.**
