**WRIT OF ELECTION FOR A REPRESENTATIVE OF THE  
PEOPLE FOR THE ELECTORAL CONSTITUENCY OF  
TONGATAPU 1**

**(SECTION 6)**

**To the Electoral Commission:**

**WHEREAS** the 2017 General Election for a Representative of the People for the Electoral Constituency of Tongatapu 1 resulted in the election of Samuela 'Akilisi Pohiva;

**AND WHEREAS** the seat of the Representative of the People for the Electoral Constituency of Tongatapu 1 has become vacant under section 6 of the Legislative Assembly Act (Cap.4), due to the death of the Samuela 'Akilisi Pohiva on 12 September 2019;

**NOW THEREFORE** in exercise of the powers vested in me by clause 76 of the Act of the Constitution of Tonga and section 6 of the Legislative Assembly Act (Cap.4), I comand that you do cause an election to be held according to the law, to elect a successor to sit and vote in the Legislative Assembly as the Representative of the People for the Electoral Constituency of Tongatapu 1 and that you make return to me of the name of such member when so elected.
