CUSTOMS TAX ACT 2007

(Section 3(1)(b))

ORDER

IN EXERCISE of the powers conferred by section 3(1)(b) of the Customs Tax Act 2007, the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order –

- (1) that all imports of food items and personal consumer goods not for commercial purposes shall be exempt from customs duty;
- (2) that this Order shall expire on the **30th of June 2020**; and
- (3) that this Order shall come into force on the date of gazettal.

- (3) kuo pau ke kamata ngaue'aki 'a e Tu'utu'uni ni 'i he 'aho 'o e kasete.

ORDER

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order –

- (1) that the supply of fish, not including processed fish shall be zero rated for consumption tax purposes;
- (2) that this Order shall expire on the **30th of June 2020**; and
- (3) that this Order shall come into force on the date of gazettal.
