CONSUMPTION TAX ACT 2003**(Section 5(3)(a))****ORDER**

IN EXERCISE of the powers conferred by section 5(3)(a) of the Consumption Tax Act 2003, the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order -

- (1) That import of a single barge craft vessel by Ports Authority Tonga, which arrived on 23 April 2020 shall be exempted from consumption tax; and
- (2) That this Order shall come into force on the date of gazettal.
