- (b) any income tax due prior to this Order shall remain payable.
- (4) This Order shall come into force on the date of gazettal.
- (5) This Order shall expire on 30 June 2026.

INCOME TAX ACT [CAP 11.05]

(Section 5(1))

ORDER

IN EXERCISE of the powers conferred by section 5(1) of the Income Tax Act [CAP 11.05], the Minister responsible for revenue and customs, with the approval of Cabinet makes the following Order -

- (1) That all income tax applicable to salaries and emoluments of local employees of the World Bank shall be revoked.
- (2) That local employees of the World Bank means local citizens, local subjects and other local nationals directly recruited by the World Bank as employees of the World Bank under the Agreement between Kingdom of Tonga and International Bank for Reconstruction and Development/International Development Association and the International Finance Corporation regarding the Establishment and Operation of Office in the Kingdom of Tonga.
- (3) For the avoidance of doubt, the revocation of income tax in paragraph (1)—
 - does not apply to local citizens, local subjects and other local nationals engaged in projects funded by the World Bank; and
