Detainee Name: Daniel Harry

Decision: His application is approved for release on parole. He is to remain on parole on strict conditions until his SED on 20/05/2024. Should he breach any conditions whilst on parole, he will be recalled to serve the remainder of his sentence.

Release Condition:

- -To be supervised directly by the Probation Officer in vila
- To undertake Spiritual Counselling by Elder Grand Joshua from the SDA Church
- To Undertake "Niufala Rod Program" as directed by a Probation Officer
- To reside at Black Sand as his residential location
- Not to re-offend at anytime
- Relaps prevention programs and victim awareness
- Find a job and start his own Joinery Business

Release Date: Within I week from the date of decision

Detainee Name: Katipa Kermit

Decision: His application is approved for release on parole. He will remain on parole under strict conditions until his SED on 15/05/2023. Should he breach any conditions whilst on parole, he will be recalled to serve the remainder of his sentence. He has a good work plan but it must be monitored by the probation officer to ensure it is established after his release and is workable thereafter for his benefit. His plan is an Agricultural Initiative. We recommend his Probation officer assist him complete an appropriate form to enable his become a member of the Agriculture Farmers Association.

Release Condition:

- Undertake the Niufala Rod program from the Probation services
- Avoid re-offending
- Undertake Rehab Programs as well as Church Programs
- Reside at Launaula Village, Tanna Island, and be under the supervision of a Community Justice Supervisor which will be appointed and set up by the Prohation Services.
- Not to travel elsewhere from the proposed resident/location without approval from the Probation Officer.

Detainee Name: Kalo Willie

Decision: His application is approved for release on parole. He will remain on parole under strict conditions until his SED on 09/08/2024. Should he breach any of his conditions whilst on parole, he will be recalled to serve the remainder of his sentence. We note his sentence plan lacks details. His probation officer should assist him further with them and to monitor their establishments and operation.

Release Condition:

- Undertake the "Niufala Rod Program" from the probation services
- Undertake rehab programs as well as church programs as directed by the probation officer
- To help complete the church house at pele village, Tongoa island as part of his rehabilitation
- To be supervised by chief Erick Pakoa Marakiwola and chief Tariliu Kalo till sentence end date
- To reside with his father and families at Freshwota 1 and not to change any location without prior from the probation.
- Not to make contact with the victim whether indirect or direct without approval
 of the probation officer
- Not to re-offend

Decision: His application is approved for release on parole. He will remain on parole under strict conditions until his SED on 09/08/2024. We note his work plan, it is lacking in details but we recommend his probation officer to assist him get started and to monitor their operations there after until his SED.

Release Condition:

- To be supervised by Thomspon Pakoa Kokona
- To undertake Spiritual counselling with Rodney Pakoa
- To perform a custom ceremony to his chief and the community of freshwota school for painting a bad picture to the community
- To undertake "Niufala Rod Program" as directed by a Probation officer
- To undertake any rehabilitation program directed by the probation officer
- Not to re-offend

Decision: His application is approved for release on parole to remain under strict conditions until his SED on 10/01/2022. Should he breach any conditions whilst on parole, he will be recalled to serve out the remainder of his sentence. He lacks a project plan but recommend a probation officer assists him and to monitor him to find a job and starts some kind of an agricultural project at Erakor where he will be residing. Once started he too can be assisted to become a member of the Agricultural Farmers Association for his future benefits,

Release Condition:

- Must return to Erakor village, Efate and be under the supervision of a community justice supervisor which will be appointed and set up by the probation services
- Undertake rehab programs as well as Church programs
- Undertake "Niufala Rod Program" from the probation services
- Part take in construction work as part of his rehabilitation programs
- Avoid re-offending

Detainee Name: Presly Taur

Decision: His application is approved for release on parole to remain on strict parole conditions until his SED on 11/10/2021. Should he breach any conditions whilst on parole, he will be recalled to serve out his remainder of the sentence. We note his work plan. Whilst it is good it lacks details and does not look realistic. He must be serious about these and do his best to see he starts something after his release. His probation officer will keep monitoring him and his projects to ensure they are started and functioning to his benefits.

Release Condition:

- Undertake "Niufala Rod Program" from the Probation services
- Undertake rehab programs as well as church programs
- Reside at Erakor half road, efate island, and be under the supervision of a community justice supervisor which will be appointed and set up by the probation services
- Not to travel elsewhere from the proposed resident/location without approval from the probation officer
- Avoid re-offending
