Fist witness blong Titus Malehi : **Micah Josuah** blong Malakula, sworn
Hemi born long 1940 long Malo.

"Hemi talem se hemi pem graon long Amabelao long papa blong Titus.
Taem hemi pem graon i no gat man hemi disputim. Hemi walkbaot long Aanimoli wetem olfalla Tchina Naboe taem ia nao Tchina Naboe hemi showem Babatavera long witness. Taem Witness hemi handem ova money Georges Liflif, David mo Vevanuaturu oli present. Oli talem se graon hemi blong Titus.
Long wan question blong Kot hemi talem se Babatavera hemi wan creek..."

Sekond witness blong **Titus Malehi** : Joel Uriuri sworn :
Hemi born long 1920 long Asavakasa;

"Hemi talem se hemi born long Tarivusi we hemi stret papa blong hem mo Molitake Vanua hemi adoptem hem. Molitake Vanua hemi best friend blong Tchina Naboe long saed blong killim pig mo helpem each other. Oli no friend from graon.

Hemi look Molivakalima, taem ia witness hemi about 12. Molivakalima hemi gat 6 fingers, wan saed hand blong hem i foldaon smol. Hemi look brata blong Molivakalima too wan Natu Karae.

Liflif mo David tufalla hemi brata, but Tarivaginogino hemi no pem Bride price blong mama blong Liflif.

Hemi harem about Arumera be hemi no lookim hem. Hemi harem about Wariwari too be hemi no lookim hem. Molviria hemi wan devel. Hemi look Susurave, hemi wan smol man nomo ; hemi no stap shave, cheekees blong hem oli olsem blong woman.

Witness ia hemi oldest witness mo hemi givim impression se hemi stap talem olgeta stret toktok hemi no save tumas long saed blong kastom histri blong olgeta klemants so hemi no ansa long olgeta questions blong olgeta.

But hemi ansa long Sawa long saed blong boundri, mo hemi talem se Babatavera hemi stap long wan Nagai tri. Nagai tri ia hemi grow stret long mark we Tchina Naboe hemi stap talem long hem. Nagai tri ia hemi stap close up long haos blong Peter Talivo.

Long question blong Kot hemi ansa se hemi gat wan sista but hemi no gat right long graon blong papa blong tufalla. Hemi givim graon long olgeta nephew blong hem finis (olgeta pikinini blong sista blong hem) Redredia hemi wan kastom blong mekem se olgeta pikinini we oli born long sista blong hem oli look save uncles blong olgeta nomo. Hemi no gat meanin long saed blong graon. Bosbosia hemi wan strong kastom, we hemi meanim se sapos wan hemi burem wan ded man we i gat graon bambae hemi tekem graon blong hem. Hemi givim example long hem : se hemi no gat pikinini hemi neva maret, but hemi gat graon blong natural papa blong hem mo adoptif papa blong hem. Sapos hemi sick mo ded man we hemi lookaotem hem mo berem hem bambae i tekem every graon blong hem..."

Kastom words we kot hemi usim long decision blong hem :

1. BOSBOSIA = Kastom blong ownem graon blong wan man we hemi no famili wetem . But from we hemi berem hem long kastom hemi gat raet blong klemem graon blong ded man.

2. REDREDIA = Kastom we wan sista hemi must givim sam samting or pem some value i go long olgeta brata blong hem blong introdusim olgeta pikinini blong hem long uncle blong olgeta.

2. BABATAVERA = Wan Bigfalla Kastom boundry we hemi seperetem olgeta man long West mo long East.

JUDGMENT

Followem olgeta evidence mo after we Kot hemi go walkabout long graon we i stap long dispute, kot hemi findem se ie gat 2 samting we hemi must mekem :

1. Kot i must decide long 1 big Boundri mark
2. Kot i must findem identity blong olgeta man we olgeta klemants oli basem klem blong olgeta long hem.

BOUNDRI :

Graon we bambae Kot ie mekem decision long hem hemi graon we i stap long map we clerk blong Santo/Malo Island Kot Heilen Rose Aru hemi putum long notice (Part title 706, start long warf go stret long cattle gate long white road go kasem creek mo babatavera long map blong Rasu mo coverem up smol Aeland Suensulaigre. Kot hemi must mekem ie clear too se bambae hemi no save followem title blong decide long kastom boundries; mo any mark we oli just katem less then 20 years nomo. Kot hemi save mo olgeta evidences we oli kamaot oli confirmem se olgeta Native before oli no save olgeta measurements, mo taem oli salem graon oli pointem direction nomo, but olgeta white man oli mekem "Self-Service". Plante taem yumi look round long Vanuatu se whiteman oli makem olgeta big Aria.
So bambae Kot i must putum boundris blong hem followem evidence we i kamaot long Kot mo long visit long Land. Olgeta Kastom advisas oli talem too se long kastom marks blong graon oli run followem sun. (Sun hemi kerap long East go long West so wan point mark blong boundri bambae hemi run i go long east.)

BABATAVERA :

Ie gat bigfalla confusion long ples ia. Olgeta klemants oli save se ie gat wan Babatavera long Aria ia but Kot i no save identifaem followem olgeta evidences from evidences we long Babatavera : Kot i tekem white road long West i go long East. 1st wan Peter Talivo hemi putum Babatavera long 1 melek tri long right saed blong road. Sekond Liflif, Tom Rasu mo Malehi oli putum Babatavera long wan mango tri long left saed blong road about 500 metres from mark blong Peter. Namba 3 witness blong Malehi, Uriuri hemi pointem out nagai tri we hemi givim evidence long hem long kot se hemi Babatavera, hemia about 500 metres from mango tri, few sekond afta, Sawa hemi arrive mo pointem sem Nagai tri.

Taem Magistrate hemi askem se sapos oli folowem stret line i go down long solwota bambae oli kamaot where. Everyone oli talem se bambae oli go kamaot stret long head blong water.

Kot hemi putum boundri blong Babatavera stret long head blong water i go long Nagai tri mo stret line go kasem creek

Olgeta evidences we oli supportem findings ia :

1. Olgeta man West oli tekem shell blong West saed blong riva olgeta man East long East saed.

Igat toktok i kamaot se hemia hemi wan agrimen nomo from i gat shell ia long Malo Pass nomo. Sapos i tru olsem bambae i must gat some kind kastom ceremony blong allowem West oli crossem Babatavera blong go tekem shell. But kot i no gat evidence long saed ia. Babatavera hemi wan big kastom boundri tumas we olgeta man bifo oli must respectem.

2. Ie gat 2 heads blong water, hemi natural nomo se i gat wan blong East mo wan blong West, from water hemi necessary long laef blong human being.

3. Main klement Rasu hemi followem title nomo.
But 3 narafalla klements we oli talk about kastom boundries blong Asuleka oli stop long middle blong Riva or narasaed riva (Luk map B, C, E)

4. Oldest witness long Kot we hemi witness blong Malehi, hemi wan gud mo valuable witness ; hemi contradictim mark blong Malehi, Liflif mo Rasu mo putum mark followem boundri we papa blong Malehi hemi putum.

5. First sale blong Aria ia hemi start long middle blong riva blong markem Asuleka Mo ie gat evidence we ie talem se Babatavera hemi folowem smol creek. Kot hemi refer long wan Map blong Malo mo noticim wan smol creek long head blong riva. (Lookim map F. long back blong page ia.)



Ie gat 3 main figures long klem ia :

MOLIVAKALIMA :

Hemi wan olfalla we hemi born somewhere long aria ia. History blong hemi no clear. But evidence oli showem se Molivakalima hemi last man Malo Pass mo hemi last man blong salem graon long Malo Pass. Kot hemi holem thinkthink ia se Molivakalima hemi wan Hero blong salem graon from olgeta exhibit oli showem se hemi stap long every deeds blong sale blong graon, some times hemi salem mo some times hemi interprete nomo. So hemi wan man we hemi save language blong white man smol. Molivakalima hemi no gat stret pikinini blong hem, but hemi gat blood line i stap.

VEVANUATURU

Hemi wan woman we hemi generation behind long Molivakalima. Woman ia now hemi stap relatet olgeta main kastom story blong Aria ia long Generation blong olgeta klemants long Kot todei.

Woman ia hemi wan long olgeta direct bloodline blong Molivakalima. But hemi hard blong understandem bloodline connection blong hem. Evidence i showem se hemi stap holem some right followem Molivakalima.

ARUMERA

Hemi wan man we hemi salem graon ia Aanimoli long Tutu Namoli, which is showem se hem no stealim graon from Tutu Namoli, evidence i showem se hemi direct line blong Molivakalima. Kot i holem se Arami we i stap long deed of sale hemi sem man ia Arumera. Arumera hemi salem Nadiutu too (Long ples ia Molivakalima hemi stap bakeken. Question se hemi kam olsem vendors or interpreters ?) Olgeta evidences i no opposem sale blong Arumera long Nadiutu mo Aanimoli.

Evidence i showem se hemi nomo gat bloodline i laef tudei. Evidence i showem too se every blood blong hem oli ded wetem Tarivaginogino.

Wan Question i no clear se Arumera hemi man West or East. Kot i no go dip insaed long ples ia. Mo too i no gat strong dispute long saed ia. Ie gat evidence we i talem se Vuti Namoli hemi famili wetem Molivakalima, sapos i tru olsem, then Vuti Namoli hemi blong East so hemi stret nomo blong hemi graon long West.

Kot bambae hemi decide se graon long East hemi go long right blong Molivakalima mo olgeta graon long West down long solwota i go long Arumera from hemi salem mo andap long bush oli go long Maratave famili mo ol man west we Sawa hemi representem olgeta mo hemi klemem.

Kot hemi look se klemants Tom Rasu, Georges Liflif, Peter Talivo oli wan famili nomo so bambae Kot hemi must sherem graon ia.

Constitution Chapter 12 section 71 hemi talem se every graon insaed long country ia hemi blong kastom ownna mo olgeta descendants blong olgeta.
Section 72 hemi talem se bambae decision blong ownaship blong kastom ownna hemi kamaot long kastom lo.

Bigfala question long case ia se pikinini blong pig hemi strong kastom lo blong Malo. Island Kot ia hemi Kot blong Santo/Malo mo hemi should followem wan general kastom lo.

Sam evidence hemi showem se priority blong kastom ownership hemi blood after pig.

Long Policy blong Malvatumauri section 1 hemi talem olsem : "Man we i true Kastom ownna blong land, hemi man we blood blong hem ikam out stret long nakamal. Varea or Nasara we kraon ia istap long baondri blong hem. Mo history blong man ia ikam out long Nasara ia....

Constitution hemi talem too long section 5 ... Bambae i no gat descrimination long saed blong sexe... Long foret blong Kot everyone oli must treatim olgeta equalli... Hemi tabu blong dipraevem one man or woman long olgeta properti we hemi gat raet long hem...

So bambae Kot ia hemi mekem decision long case ia followem Bloodline mo no save leavim right blong wan woman, from Constitution hemi ova raedem kastom.

Wetem think think antop mo followem evidence we i stap we i showem se plante long olgeta graon ia olgeta man blong olgeta oli lus everyone finis Kot hemi decide se graon long East hemi blong Molivakalima mo oli dividem finis bitwin between 2 man (Molitalotu mo Molimatacu).

TOM RASU

Hemi representem famili Rasu.

Kot hemi bilieve se Rasunaboe hemi stret pikinini blong Molimatacu.

Molimatacu hemi bloodline blong Molivakalima.

Kot hemi believem histori blong Tom Rasu from ie gat evidence we oli supportem histori ia. But oli no wandem recognisem right blong Tom Rasu from se oli no pem mama blong hem.

Way we Vevanuaturu hemi stap act towards Tom Rasu hemi suggest se Vevanuaturu hemi save se Rasunaboe hemi cousin blong hem but hemi no gat plante right . That is why hemi talem se Rasunaboe i gat smol right nomo but hemi salem right ia finis. Hemia long Nalepa.

Kot hemi look too se Rasu oli nomo laef long area ia long taem finis. So Kot hemi givim part blong East long solwota long Rasu Famili. (Luk long map G long back page)

GEORGES LIFLIF

Hemi representem famili blong Tarivaginogino.

Kot i look se i no gat enough supportive evidence blong showem se Molivakalima hemi gat wan sista Vemolialao. But i gat some blood connection wetem Tarivaginono addem up wetem kastom Bosbosia Molivakalima. Mo too right blong David we hemi 1st born blong Vavanuaturu mo second born blong Tarivaginogino, mekem se narafalla part blong graon ia long east hemi blong famili blong Tarivaginogino, we Liflif hemi representem olgeta today. Long saed blong NADIUTU MO AINIMOLI we Arumera hemi owna blong hem i go long Tarivaginogino bakeken followem bosbosia blong Arumera we Tarivaginogino hemi mekem wetem sista blong Arumera. Evidence long saed ia hemi strong blong showem se blood blong Arumera mo sista blong hem oli sting nomo long leg blong Tarivaginogino. (Luk map G long back page)

SAWA MATARAVE

Hemi representem Matarave famili.

Hemi no talk about tumas histori connection wetem olgeta 4 narafalla klemants, but interest blong hem i stap nomo long position blong Babatavera we kot hemi mekem decision long hem finis. Graon blong olgeta hemi start behind long Nadiutu mo Aanimoli i go kasem creek.

Kot hemi no look long each boundri long aria blong West. Sawa hemi assurem
Kot se hemi wetem olgeta blong West oli save stretem boundri blong olgeta
nomo.

PETER TALIVO

Hemi stanap hem wan nomo

Kot hemi clear se Vevanuaturu hemi girl blong Molitalotu we hemi brata blong Molimatacu. Taem case ia istap come antap Kot i look se Vevanuaturu hemi stap occupaem mo mekem business wetem graon antop long hill mo each taem we hemi wandem salem wan birth right blong hem i go long Peter hemi must usum Liflif blong katem boundri, eventhough David mo Vutinamoli tufalla i stap. Thinkthink ia long Kastom bambae hemi meanim se Vevanuaturu hemi considerem se Liflif now hemi head blong olgeta pikinini blong hem. Recent wan long 1988.

Long last ceremony blong Peter hemi pem right ia Vutinamoli hemi no present. Peter himself insaed long Kot hemi talem se hemi pem out right blong uncle blong hem Vutinamoli finis, bambae olgeta i nomo gat right ; hemi suggest se hemi stanap blong disputim kastom graon ia long nem blong hem wan nomo. So hemia hemi showem long kastom se Peter hemi stap pem Kastom right blong Vevanuaturu long foret blong uncles blong hem, long some specific boundri nomo.

Kastom right hemi wan right we man or woman hemi born wetem, yumi no need blong pem. Hemi olsem wan heritage, we hemi pass automatic nomo long

ancestors i go long descendants. Hemi sem mark long Will, hemi wan fri samting we wan owna hemi likem blong givim out long anyone we hemi wandem. Long wan decision blong Acting Chief Justice Goldsbrough long Vanuatu Supreme long case blong Matantas hemi talem se "...Custom ownership means that land is held in trust by the declared custom owner for the benefit of all the people who originate from or live in that area. It does not mean that the benefit of the land goes to any individual person. If that were allowed to happen then there may well be nothing left for successors....It is like the crown Jewels of England. The Queen may use them whilst she remains the monarch but she may not sell them but must keep them for the next monarch. The same must apply to a custom owner, who has a duty to keep his land intact for the next generation..." Yumi must save se graon hemi no blong wan individual. Right blong Peter Talivo bambaie i stap nomo long olgeta Aria we hemi pem, hemia long Belavocotavera we Georges Liflif hemi markem mo showem long hem.

Long saed blong klem blong Peter Talivo long Nadiutu. Hemi hard blong Kot hemi look save right we Peter Talivo hemi klem. From evidence hemi showem se Arumera hemi ded, hemi leavim right long sista blong hem. Mo sista blong hem hemi ded, hemi leavim right ia long Tarivaginogino. First blood blong Tarivaginogino hemi Georges Liflif so right ia hemi should followem Georges Liflif.

TITUS MALEHI

Klemant ia hemi kam wetem wan completly new kastom story. Ie no gat supportif evidences mo too witness blong hem we hemi oldest man hemi brave enough blong showem boundri blong Babatavera we hemi contradictim boundry blong 3 klemants includim Titus we witness hemi givim evidence blong supportem case blong hem. Boundri we hemi showem hemi sem boundri we Tchina Naboe hemi showem long hem some 70 years oli pass finis. So klem blong Titus Malehi hemi must failed.
