3. Withdraw form, sign bai MR. Livai Gorot em one - but i no wetem Douglas Richard we tufala i responsible Gung tekemot money -
4. I no kat any member Gung Community we i receiving payment long ol work we hemi mekem Gung Community -

So Court, orderem Defendant blong payem i go long Plaintiff the sum of \$7,960 Plus \$2000 Court fee - Total : \$9,960 -
