Plaintiff i questionem witness =

" Mifala i plenty we i harem toktok ia ?  
- Yes mifala i fulap wetem some woman too.

Defendant i questionem witness =

Long taem i who i talem se mas wremment ol bikinini ?

" - Ju nao ju talem se ol bikinini i no mas nearem wearem bea ju talem - so tumi bin talem long ol bikinini long go way - "

Second Witness - MR. Frank Pollen long Vetiboso Vanualewa - i swear wetem Bible mo talem =

"Yes me too me been present long taem we MR. Graham Murney i storian - Me supportem mo confirmem se everysamting we Jonaston Manar i talem i true - Braham i talem se Daniel Golow nao i poisenem Paul Kio."

Defendant i questionem Witness -

"Ju been present true long time ia, from no remember se ju been stap wetem mi feela?"
