Defendants'plea "Me no guilty dong case ia from faol we dog i killim ino  
blong Samson Keker but hemi blong Pastor Alick"

Justice : "Case igo long trial".

Clerk i puttum ol witnesses blong case igo far away .

Plaintiff ino tekem any witness.

Defendant i tekem three witnesses :

1. John Petteson, i swear wetem Bible mo talem "Yes me save talem se dog  
killim faol we i blong Pastor Alick but ino blong Sam. Problem ia i  
solvem finis. Kingsford i givim back faol ia long Pastor Alick mo Elsy  
wife blong hem.

Plaintiff i questionem witness No.I "Did yu save kala blong faol we dog  
i killim ?

A.- Wan red roasta faol mo hemi blong ps Alick.

Plaintiff-"Me save se yu kiaman - faol we dog i killim hemi wan black indian."

2. Armstrong, i swear wetem Bible mo talem "Faol we dog i killim hemi wan  
red man faol, hemi blong ps Alick mo Elsy."

Plaintiff "Long first ples yu mo Kingsford i talem long me se wan black roasta  
faol, tede yutufala i changem toktok".

Armstrong"Yu yet yu forcem me blong me mas talem se hemi wan black indian faol".

Plaintiff i swear wetem Bible mo talem "Faol we dog i killim mo olgeta ia  
kakai, i closap long yard blong me, long fence blong olfala Elman.Haos blong  
Pastor Alick i far away long area we dog i killim faol long hem."  
"Mo faol i blong me wan black roaster faole."

- Court i findem se dog i kilim faol closap long area we Samson i live  
long me hemi far away long ples we ps Alick i live long hem.
- faol hemi wan black indian faol we i belong long Samson.

DECISION OF COURT :

The Court Orders the Defendant to pay to the Plaintiff the sum claimed  
together with the Court Fee. Total to pay VT.2,750. To be paid within 2  
month.
