Order:

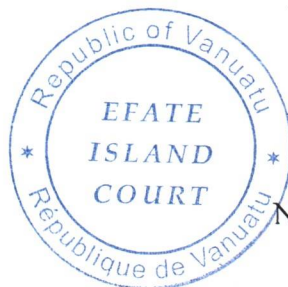
1. Se bae Kot ino strikem Counter-Claimant No.4 straight away, be bae Kot ino save harem kes blong Counter-Claimant noa ia;

5. Counter Claimant No. 4 imas pem cost long ol nara parties long kes long sum of Vt 12,500 each, mekem total blong Vatu 50,000.
6. Bae Counter-Claimant imas pem ol money ia by Friday 28 October 2011, hemia whether hemi gohed olsem parti or nokat hemi mas pem.
