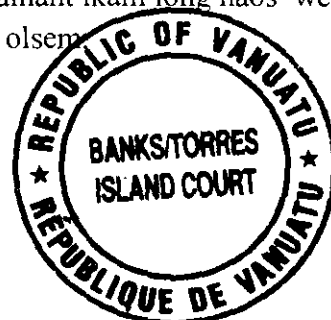
JUDGMENT




