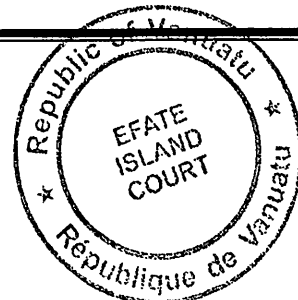
**JUDGEMENT**

The defendant, **KALMARK WATSON**, is charged with the offence and pleaded guilty to the charges of **IDLE AND DISORDERLY (COUNT 1)**, against section 148, Penal Code Act Cap 135 and **MALICIOUS DAMAGE TO PROPERTY (COUNT 2)**, against C/S 133, Penal Code Act Cap 135.

The facts provided by the prosecutor states that on the 31<sup>st</sup> of July 2013 at Sea-side Tongoa Public Road, **KALMARK WATSON** was drunk intoxicated alcohol liquor and found acting in a disorderly manner. He also damaged Mr. James Aru's car by punching its rear body and bend it.

Having heard the evidence provided by the defendant;  
**THE COURT HEREBY MAKES** the following Orders:


1. Mr. Defendant **KALMARK WATSON**, to pay 2'500vt Prosecution Cost Fine for **count 1**;
2. Also pay 3'500vt Island Court Fine for **count 1**;
3. Mr. Defendant **KALMARK WATSON** to pay 4'000vt Prosecution Cost Fine for **count 2**;
4. Also pay 3'000vt Island Court Fine for **Count 2**;
5. All Payment (**Total : 13'000vt**) must be paid directly to the Government Cashier at the Finance Department – Government Building and provide the court and prosecution copy of the payment receipt;




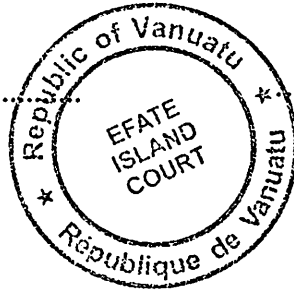
6. Payment must be made within 21 days as from today (*Due Date : 07<sup>th</sup> May 2014*);
7. Mr. Defendant has the right to appeal within 21 days as from today.


