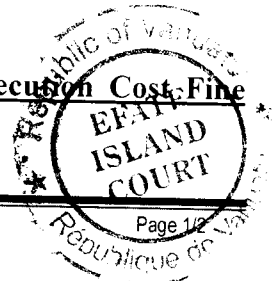
JUDGEMENT

COURT IA HEMI STAP MEKEM ORDER OLSEM:


1. Defendant ia STEVEN IATIKA i must pem 4'000 vatu olsem Prosecution Cost-Fine
(Count 1 : 2'000vt mo Count 2: 2'000vt);




2. Mo must pem **6'000vt** olsem **Efate Island Court Fine** (*Count 1 : 3'000vt mo Count 2: 3'000vt*);

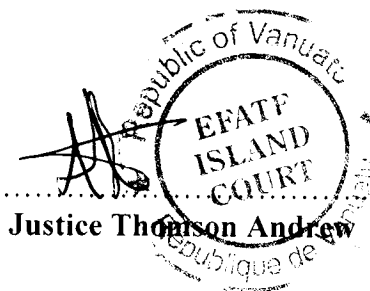
