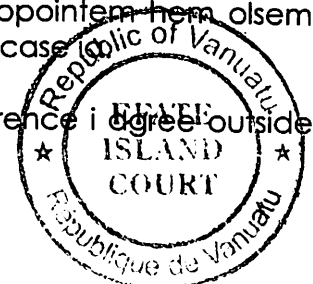


STRUCK-OUT ORDER


