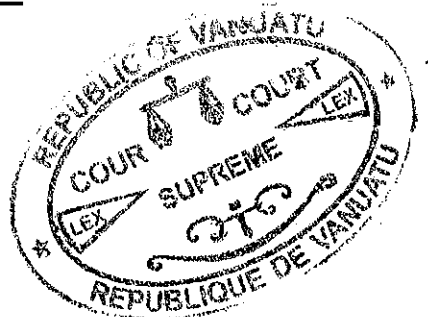

BY CONSENT the Parties agree that:

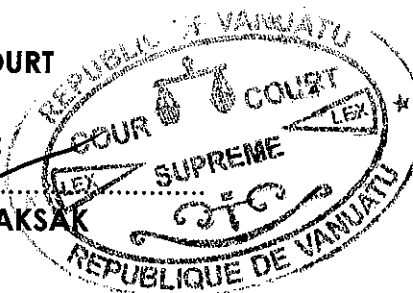
1. The Interested Party, Gracia Shadrack will tender his resignation as the Speaker of Parliament on execution of these Consent Orders;
