QUEEN'S REGULATION

TO MAKE provision for the jurisdiction of the High Court of the New Hebrides and for the adaptation of existing laws.

MADE BY Her Britannic Majesty's Resident Commissioner in the New Hebrides in pursuance of the powers contained in the New Hebrides Orders. In the name of Her Majesty Elizabeth the Second, by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and Her other Realms and Territories Queen, Head of the Commonwealth, Defender of the Faith.

terpretation

- 1. This Regulation may be cited as the High Court of the New Hebrides Regulation 1976 and shall come into operation on the date of commencement of the Order.
- 2. In this Regulation, unless the context otherwise requires -

"the amended Order" means the provisions contained in Schedule 1 to the New Hebrides Order 1973 as amended by the Order;

"the former High Court" means the High Court of the Western Pacific reconstituted by section 3 of the Western Pacific (Courts) Order in Council 1961;

"the High Court" means the High Court of the New Hebrides established by section 12A of the amended Order; "the Order" means the New Hebrides Order 1975.

Jurisdiction as to statutes of general application

5. Subject to any Regulation in force in the New Hebrides, the civil and criminal jurisdiction of the High Court shall, so far as circumstances admit, be exercised in accordance with the statutes of general application in force in England on the 1st day of Janury, 1976 and the provisions of paragraph (a) of subsection (1) of section 11 of the Order shall be read and construed accordingly.

Adaptation of existing law

- 4. (1) Subject to the provisions of the amended Order, as from the date of commencement of the Order, references in any law in force on that date or in any instrument or document made before that date to the Chief Justice of the Western Pacific shall be construed as references to the Judge of the High Court.
- (2) The Regulations set out in the first column of the Schedule are hereby amended or repealed in the respects and to the extent specified in the second and third columns thereof respectively.
