1. These Rules may be cited as the Dealers in Securities (Licences) Rules 1977 and shall come into operation on the day upon which they are published by the Resident Commissioner causing a copy thereof to be exhibited at the Public Office of the Resident Commissioner.
2. An application for a principal's licence made under section 5(1)(a) of the Prevention of Fraud (Investments) Regulation ("the Regulation") shall be submitted to the Registrar of Companies in the form prescribed in the First Schedule.
3. An application for a representative's licence made under section 5(1)(b) of the Regulation shall be submitted to the Registrar of Companies in the form prescribed in the Second Schedule.
4. The fee of \$A 25 shall be submitted with every application for a principal's licence.
5. The fee of \$A 15 shall be submitted with every application for a representative's licence.
