JOINT REGULATION

No. 25 of 1974

TO AMEND the Export Duties Joint Regulation No. 6 of 1964.

MADE by the Resident Commissioners under the provisions of Articles 2:2, 5:2, and 7 of the Anglo-French Protocol of 1914.

Replacement of Schedule I to J.R. No. 6 of 1964

1. Schedule I to the Export Duties Joint Regulation No. 6 of 1964 (as amended by J.R. No. 12 of 1973) is hereby repealed and replaced by the following schedule -

SCHEDULE I

EXPORT DUTIES PAYABLE

Part A. Ad valorem duty

Goods and Products

Copra: when the price, for the purpose of calculating the amount of duty payable, falls within the limits specified below, the following rates of duty shall apply :-

(a)	FNH 20,001 and above per ton (metric ton)	7.0%
(b)	FNH 10,001 to FNH 20,000 per ton	5 . 5%
(c)	below FNH 10,001 per ton Maximum	3 . 5%

Provided always that where the price of copra as calculated above falls below FNH 10,001 per ton no duty shall be payable until the Resident Commissioners, after having consulted the Advisory Council or the Standing Committee thereof, fix the rate of tax (if any) best adapted to the current economic circumstances.

Cocoa	6%
Coffee	3%
Fish, frozen (other than high seas squid)	4%
Fish, frozen, high seas squid	3%
Meat, frozen	2% 10%
Trochus, Green Snail and other shells	
Sandalwood	6%
Miscellaneous products and articles not	
specified	2%

Part B. Specific Duties

Kauri Pine; logs and roughly

Specific rate 41.6 FNH or the equivalent in Australian Dollars at the official rate of exchange per cubic metre

Kauri Pine, Sawn Timber

Specific rate 20 FNH or the equivalent in Australian Dollars at the official rate of exchange per cubic metre

Timber of all species other than Kauri Pine; Logs and roughly squared Timber Specific rate 41.6 FNH or the equivalent in Australian Dollars at the official rate of exchange, per cubic metre

Scrap Metal : Ferrous

Specific rate 87.5 FNH or the equivalent in Australian Dollars at the official rate of exchange, per ton

Non-ferrous

Specific rate 1,750 FNH or the equivalent in Australian Dollars at the official rate of exchange, per ton.

Citation and Commencement

2. This Regulation may be cited as the Joint Export Duties (Amendment) Regulation No. 25 of 1974 and shall come into operation on the date of its publication in the Condominium Gazette.
