THE JOINT VALIDITY OF MARRIAGES REGULATION (AMENDMENT) ACT No. 34 OF 1981

To provide for the application of the Joint Validity of Marriages Regulation No. 16 of 1970 to persons generally, and for the appointment of District Registrers and for other matters.

Bo it enacted by the President and Parliament as follows :-

- 1. The Joint Validity of Marriages Regulation No. 16 of 1970 is amended by :-
 - (a) the substitution of the word "person" for the words "New Hebridean" and the word "persons" for the words "New Hebrideans" throughout the Regulation;
 - (b) the substitution of the word "Minister" for the words "Resident Commissioners" throughout the Regulation;
 - (c) the deletion in Section 1 of the words in brackets;
 - (d) the repeal of Section 2 and the substitution of the following therefor:
- "2 (1) District Registrars shall be appointed by the Minister and their appointments shall be notified in the Gazette.
 - (2) The instrument of appointment of a District Registrar shall declare the district within which he may colebrate marriages.
 - (3) The jurisdiction of each District Registrar shall be limited to the District to which he has been appointed. The Minister may appoint an additional District Registrar to a District who shall exercise concurrently with the office holder the functions conferred upon him by this Régulation."
 - (a) the substitution in Section 5 of the English text of the word "residence" for the word "domicile";
 - (f) the substitution of the word "Vanuatu" for the words "New Habrides" throughout the Regulation;
 - (g) the substitution of the word "premises" for the words "District Agency" throughout the Regulation;

- (h) the addition at the end of the Regulation of the following section :
- The Minister may by order prescribe fees payable on the celebration of marriages, $\boldsymbol{\pi}$ "23
 - (i) the deletion of Form A from Schedule 1 and the substitution therefor of the following :
