

REPUBLIC OF VANUATU

JOINT RULES (AMENDMENT) ORDER NO. 23 OF 1984

To amend the Joint Control of Access to Public Service Airfields Rules No. 12 of 1974.

IN EXERCISE of the powers conferred by section 1 of the Joint Control of Access to Public Service Airfields No. 24 of 1974 -

1. Paragraph 3 of the Joint Control of access to Public Service Airfield Rules No. 12 of 1974 (hereinafter called the Principal Rules) is hereby repealed and replaced as follows -

"3. (1) The only persons who shall have access to the terminal area of the reserved zone shall be :-

(a) Persons who display one of the access passes described in Schedules 1, 2 and 3 of the Principal Rules.

(b) Passengers embarking on or disembarking from an aircraft who have in their possession a ticket issued in respect of the flight just completed or about to commence.

(c) Police officers, provided that such officers shall have due regard for the provisions of Joint Rules No. 13 of 1974.

(2) The only persons who shall have access to the technical areas of the reserved zone shall be :-

(a) Persons who display one of the access passes described in schedules 1, 2 and 3 of the Principal Rules.

- (b) Police Officers, provided that such officers shall have due regard for the provisions of Joint Rules No. 13 of 1974.
3. Fees may be charged for the issue of the passes described in Schedule 2, such fees to be decided by the Director of Civil Aviation."
 2. This Order shall come into force on the date of its publication in the Gazette.
