## CHAPTER 168

## OFFICIAL SALARIES ORDER No. 22 OF 1991

An Order to amend the Schedule to the Official Salaries Act [CAP. 168].

IN EXERCISE of the powers conferred by section 3 of the Official Salaries Act [CAP. 168], I, DONALD KALPOKAS, Prime Minister and Minister of Justice and Public Service, with the prior approval of the Council of Ministers, hereby make the following Order:-

#### AMENDMENT OF PART 1 OF THE SCHEDULE TO CHAPTER 168

- 1. Part 1 of the Schedule to the Official Salaries Act [CAP. 168] in this Order referred to as "the Act", as amended, is further amended as follows:-
  - (a) in column 1 by inserting after "Prime Minister" the words "Deputy Prime Minister";
  - (b) in column 2 by inserting after "1.936.000" the figure "1.836.000" corresponding to "Deputy Prime Minister" in column 1;
  - (c) in column 3 by inserting after "A + D + E + G" corresponding to "Prime Minister" in column 1 the figures "B + C + D + E + G" corresponding to "Deputy Prime Minister" in column 1;
  - (d) in column 3 by inserting before "B +" the figure "A(a)
    +" corresponding to "Speaker" in column 1;
  - (e) in column 1 by inserting after "Speaker" the words "Deputy Speaker";
  - (f) in column 2 by inserting after "1.758.178" corresponding to "Speaker" in column 1 the figure "1.369.060" corresponding to "Deputy Speaker" in column 1;
  - (g) in column 3 by inserting after "B + C + D + E + G" corresponding to "Speaker" in column 1 the figures "D + E + G + J" corresponding to "Deputy Speaker" in column 1.
  - (h) in column 1 by inserting after "Minister" the words "Leader of the Opposition";

- (i) in column 2 by inserting after "1.742.400" corresponding to "Minister" in column 1 the figure "1.369.060 corresponding to "Leader of the Opposition" in column 1;
- (j) in column 3 by inserting after "B + C + D + E + G" corresponding to "Minister" in column 1 the figure "E" corresponding to "Leader of the Opposition" in column 1.

# AMENDMENT OF PART 2 OF THE SCHEDULE TO THE ACT

Part 2 of the Schedule to the Act is amended in CLASS B by repealing "Furnished house at rental fixed by Government" and substituting the following words "Rent free furnished house".
