IN EXERCISE of the power contained in section 15 of the Joint Price Control Regulation No. 18 of 1974, I hereby make the following Order :-

1. The maximum wholesale and retail prices of the goods specified in the first column of the Schedule hereto shall be those set against them in the other columns of the Schedule.

3. The Schedule to this Order shall be exhibited in every wholesale or retail store or premises and every ship operated as a wholesale trader.







THE NEW HEBRIDES (PROVISIONAL) AIRCRAFT
CONTROL JOINT REGULATION NO. 12 OF 1948

PERMIT NO. 1 OF 1981

IN EXERCISE of the power contained in Section 8 (1) of the New Hebrides (Provisional) Aircraft Control Joint Regulation No. 12 of 1948, I hereby grant the following Permit :-

1. Mr. A. K. Barlow ("operator") domiciled at Vila, Efate, in the Republic of Vanuatu may carry passengers and freight by air for hire or reward on non-schedule charter flights operated within the Republic of Vanuatu but subject to the following conditions : -
 - (a) This permit is not transferable and shall apply only to the operator shall remain valid from the date hereof until revoked by the Minister and provided that the operator -
 - (i) continues to reside in the Republic of Vanuatu; and
 - (ii) does not contravene any legislation in force relating to air transport;
- Aeronautical operations of any aircraft used by or under the control of the operator shall comply with the provisions of all relevant legislation applicable in the Republic of Vanuatu;

- (c) The maximum and normal charter fee per hour for the operation of the operator's aircraft shall be fixed by the Minister. However, in exchange for the concession for services rendered to Government for missions of mercy or research and rescue operations, the fee applicable shall be at a cost price;
- (d) Apart from charters for the use of the operator's aircraft by Air Melanesiae Limited or the Government of the Republic of Vanuatu, the number of flying hours for charter operations shall be limited to 35 in any month;
- (e) The operator shall insure himself :-
- (i) in respect of liability for death or injury to passengers to an amount which shall not be less than 5 million vatu in respect of each passenger;
- (ii) in respect of damage to passengers' luggage and to freight carried on behalf of consignors; and
- (iii) in respect of Public Liability, to an amount which shall not be less than 50 million vatu.

Joint Decisions No. 6 of 1976 and No. 113 of 1976 are revoked.
