PILOTAGE FEES (AMENDMENT) ORDER  
No. 45 Of 1981

To amend Rule 12 of Joint Rules No.6 of 1973 and Rule 13 of Joint Rules No.2 of 1977.

IN EXERCISE of the power contained in Section 37 of Ports Joint Regulation 1957, I hereby make the following Order :-

1. The Joint Rules No.6 of 1973 is amended -

(a) By the repeal of Rule 12 and the substitution thereof of the following :-

"12 (a) The Government Treasurer shall remit 15% of half of the total fees levied to the pilot who has carried out the pilotage operations.

(b) Where any pilotage operation is carried out by any person other than a Government employee or public servant and provided such person is appointed by the Minister, the Government Treasurer shall remit the same amount as specified in paragraph (a) to such person."

2. The Joint Rules No.2 of 1977 is amended -


(a) By the repeal of Rule 13 and the substitution thereof of the following :-

"13 (a) The Government Treasurer shall remit 15% of half of the total fees levied to the pilot who has carried out the pilotage operations.

(b) Where any pilotage operation is carried out by any person other than a Government employee or public servant and provided such person is appointed by the Minister, the Government Treasurer shall remit the same amount as specified in paragraph (a) to such person."

3. This Order shall come into force on the date of signature.
