
1. The second quarter of the Government house numbered 139 and situated at Rue Colardeau, Port Vila, is hereby declared a prison for the confinement of women prisoners.

1. The following persons are appointed to the Police Service Commission :—



IMPORT OF CHICKEN AND CHICKEN PIECES (PROHIBITION)

ORDER NO. 12 OF 1983

To prohibit the importation of chicken and chicken pieces into Port Vila.

IN EXERCISE of the power contained in section 1 (1) of the Schedule to the Import of Meat and Fish (Control) Regulation 1979 (No. 12), I hereby make the following Order :

Interpretation. 1. For the purpose of this Order, "chicken" includes the flesh of bone and roasters.

Import of chicken into Port Vila prohibited.


2. (1) No frozen chicken or chicken pieces, other than chicken wings, shall be imported into Port Vila from any place outside Vanuatu.

(2) Where frozen chicken or chicken pieces have been imported from outside Vanuatu into an island or place other than Port Vila, no such chicken or chicken pieces shall be exported or trans-shipped to Port Vila.


Revocation. 3. The Import of Chicken and Chicken Pieces (Prohibition) Order Nos. 34 and 39 of 1982 are revoked.

Commencement. 4. This Order shall come into force on the date of its signature.






