



THE PENTECOST LOCAL GOVERNMENT COUNCIL

THE HEAD TAX REGIONAL LAW N° 2 OF 1985

To provide for a Head Tax, for the collection or payment of such tax and for matters connected therewith.

IN EXERCISE of the power contained in section 26 of the Decentralisation Act N° 11 of 1980, the Local Government Council hereby makes the following Regional Law :-

Interpretation 1 In this Regional Law unless the context otherwise requires -

"Council" means the PENTECOST Local Government Council;

"officer" means any officer employed by the council including any officer in the service of an Area Council.

Creation of Head Tax 2 There is hereby created an annual head tax which shall be known as the Head Tax.

Assessment of Head Tax 3 The head tax shall be assessed as follows :-

(a) Males _____ Vt;

(b) Females _____ Vt.

Persons Liable to Pay Head Tax 4 Subject to Section 7 every adult person who is neither less than 18 years old nor more than 59 years old, and who -

(a) is resident within the boundaries of the Council for at least six months; or

(b) intends to be resident within the boundaries of the Council for at least six months; or

(c) retains a right to property or land or other customary claims within the boundaries of the council;

shall be liable to pay to the Council the head tax as provided in Section 3.


- When Head Tax due 5 The head tax shall become payable not later than the last day in the month of October.
- Late Payments 6 In the case of late payment, the amount of head tax shall be increased by 50% provided that any amount paid shall not exceed 2,500vt.
- Exemptions 7 The following categories of persons shall be exempted from full or part payment of the head tax:
- (a) any person between the ages of 18 and 21 years, inclusive, who satisfies the Secretary or an officer authorised by him that he is a full-time student;
 - (b) any person who by reason of physical or mental disability has been specifically exempted by decision of the Council;
 - (c) any person who by reason of poverty or for any other good reasons has been specifically exempted by decision of the council.
- Head Tax to be recovered as civil debt 8 If a person fails to pay the head tax to which he is liable, the council may recover the tax due including any surcharge as a civil debt together with costs and in addition to any other penalty which a court may impose in accordance with Section 9.
- Offence 9 Any person who fails to pay the head tax shall be guilty of an offence and shall on conviction, be liable to a fine not exceeding 20,000vt or to a period of imprisonment not exceeding six months or to both such fine and imprisonment.
- Repeal 10 The Pentecost Local Government Council Head Tax Regional Law No.1 of 1984 is repealed.



LE CONSEIL PROVINCIAL DE PENTECÔTE

ARRETE PROVINCIAL NO. 2. DE 1985. SUR LA CAPITATION

Instituant la capitulation et définissant les modalités de perception ou de paiement de cette taxe et d'autres questions connexes.

LE CONSEIL PROVINCIAL

VU l'article 26 de la loi No. 11 de 1980 sur la décentralisation :

ARRÈTE

DEFINITIONS

1. Dans le présent arrêté provincial, sauf interprétation différente dictée par le contexte :

"agent" désigne tout agent employé par le Conseil, y compris tout agent travaillant au service d'un conseil départemental ;

"Conseil" désigne le conseil provincial de Pentecôte.

INSTITUTION DE LA CAPITATION

2. Par les présentes, il est créé une taxe annuelle sur les personnes physiques appelée capitation.

FIXATION DE LA CAPITATION

3. La capitation est fixée de la façon suivante :

- a) hommes 900 VT ;
- b) femmes 500 VT.

PERSONNES ASSUJETTIES A LA CAPITATION

4. Sous réserve de l'article 7, est tenu de payer au Conseil la capitation prévue à l'article 3 tout adulte âgé d'au moins 18 ans et d'au plus 59 ans, et qui :

- a) réside dans la province depuis au moins 6 mois ;
- b) a l'intention de résider dans la province pendant au moins 6 mois ; ou
- c) détient un droit de propriété ou un droit sur des terres ou toute autre revendication coutumière dans la province.

ÉCHEANCE DE LA CAPITATION

5. La taxe doit être acquittée au plus tard le dernier jour du mois d'octobre.

ARRIERES

6. Après l'échéance, la capitation est majorée de 50 % à condition que tout montant versé ne dépasse pas 2.500 VT.

EXEMPTIONS

7. Sont exemptées de tout ou partie du paiement de la capitation les catégories de personnes suivantes :

- a) toute personne âgée de 18 à 21 ans qui peut prouver au secrétaire ou à un agent habilité par ce dernier qu'elle est un étudiant à plein temps ;
- b) toute personne qui, pour des raisons d'incapacité physique ou mentale, est exemptée à titre particulier par décision du Conseil ;
- c) toute personne qui, pour cause d'indigence ou autres motifs valables, est exemptée à titre particulier par décision du Conseil.

ACTION EN RECOUVREMENT

8. Si une personne n'acquitte pas la capitation dont elle est redevable, le Conseil peut intenter une action en recouvrement de la capitation exigible, de toute majoration et des dépens ; le tribunal saisi peut en outre faire application des peines prévues à l'article 9.

INFRACTIONS

9. Toute personne ne s'acquittant pas de la capitation commet une infraction qui la rend passible, après établissement de sa culpabilité, d'une amende n'excédant pas 20,000 VT ou d'une peine d'emprisonnement n'excédant pas 6 mois, ou des deux peines à la fois.






