THE CIVIL AVIATION (AIRCRAFT LANDING FRES REGULATION) (AMENDMENT NO.1) ORDER NO.38 OF 1985

To amend the Civil Aviation (Aircraft Landing Fees Regulation) Order No.43 of 1984.

IN EXERCISE of the power contained in Section 3(1) (r) of the Civil Aviation Act No.38 of 1982, I hereby make the following Order:-

AMENDMENT OF ORDER NO.43 of 1984

- 1. The Civil Aviation (Aircraft Landing Fees Regulation) Order No.43 of 1984 is amended as follows:
 - (a) By repealing section 6 and substituting the following therefor "METHOD OF PAYMENT
 - 6. (a) The fees herein provided shall become due immediately after the arrival of the aircraft and shall, subject to the provisions of sub-paragraph (b) be payable on behalf of the owner or charterer by the Captain of the aircraft to an authorised officer of the Government at each airport.
 - (b) The fees may by prior arrangement be paid to the Department of Civil Aviation by the airline on a quarterly basis in respect of landings made by the airline during the previous three months.
 - (c) Where the fees are not paid by the airline within 30 days of the due date the Government shall recover the amount due as a civil debt".
