

THE BANKS/TORRES LOCAL GOVERNMENT COUNCIL
HEAD TAX (AMENDMENT NO. 1)
REGIONAL LAW NO. 1 OF 1986

To amend the Banks/Torres Local Government Council Head Tax Regional Law No. 1 of 1983.

IN EXERCISE of the power contained in section 26 of the Decentralisation Act No. 11 of 1980 as amended, the Banks/Torres Local Government Council hereby makes the following Regional Law:


AMENDMENT

1. The Banks/Torres Local Government Council Head Tax Regional Law No. 1 of 1983 is amended as follows:
 - (a) In section 3(a) by the deletion of the figure "1,000" and substitution therefor of the figure "1,100, and
 - (b) In section 3(b) by the deletion of the figure "500" and substitution therefor of the figure "600".

COMMENTARY

2. This Regional Law shall come into force on the date of its publication in the Gazette.
