

THE REPRESENTATION OF THE PEOPLE (AMENDMENT OF ELECTORAL REGISTRATION AREA). ORDER NO. 22 of 1986

To provide for the change of name of certain polling stations in certain electoral polling districts.

IN EXERCISE of the power contained in section 65 (1) (a) and 67 (2) of the Representation of the People Act No. 13 of 1982,
THE ELECTORAL COMMISSION HEREBY MAKES the following Order :

AMENDMENT OF LIST OF REGISTRATION AREAS.

1. The list of polling districts (which correspond to the names of polling stations) established under the provisions of Section 67 (2) of the Representation of the People Act No. 13 of 1982 is amended as follows :

- (1) in reference to the island of Santo by substituting "Wunaerei" for "Mapten", and "Navura" for "Armeulak".
- (2) in reference to the island of Epi by substituting "Rovo Bay" for "Esake".

COMMENCEMENT.

2. This order shall come into force on the date of its publication in the Gazette.
