THE LUGANVILLE MUNICIPAL COUNCIL CONTROL OF OLD, DANGEROUS
AND UNHEALTHY BUILDING (REPEAL) BYE LAW NO. 1 OF 1987

To repeal the Luganville Municipal Council Control of Old, Dangerous and Unhealthy Building Bye Law No. 2 of 1986.

IN EXERCISE of the power conferred by sections 25 and 35 of the Municipalities Act No. 5 of 1980, as amended, the Luganville Municipal Council hereby makes the following Bye Law:

REPEAL

1. The Luganville Municipal Council Control of Old, Dangerous and Unhealthy Building Bye Law No. 2 of 1980 is repealed.


COMMENCEMENT
