There shall be established a School Council which shall be known as the Malapoa College Council.

Notwithstanding the provisions of section 2, all assets including any property whether real or personal, owned by the Malapoa College Council or to which it is entitled at the date of commencement of this Order and liabilities of the Malapoa College Council are hereby vested in the Malapoa College Council established in accordance with this Order.

4. This Order shall come into force on the day of its publication in the Gazette.
