An order to prohibit the sale and supply of liquor in Vanuatu in the interest of public peace and good order during the By-elections.

IN EXERCISE of the powers conferred by 14A of the Joint Liquor Licensing Regulation No. 18 of 1968, as amended, I hereby make the following Order:

SALE OF LIQUOR IN VANUATU PROHIBITED

1. Subject to section 2, the sale and supply of alcoholic liquor at licensed premises within the Republic of Vanuatu whether for consumption on or off the premises, is hereby prohibited from 7.30 am on Monday 27th November 1989 until midnight Tuesday 28th day of November 1989.

EXCEPTION

2. Notwithstanding the provisions of section1, alcoholic liquor may be sold during the said period within the normal hours of opening in restaurants and hotels to bona fide customers for consumption with their meals.

COMMENCEMENT

3. This Order shall come into force on the 27th day of November 1989.
