CHAPTER 175

LAND SURVEYORS (REGULATIONS) (AMENDMENT) ORDER No. 9 OF 1991

An Order to increase survey fees.

IN EXERCISE of the powers conferred by section 27 of the Land Surveyors Act [CAP. 175], I, WILLIAM MAHIT, Minister of Lands, Geology, Mines and Rural Water Supply, hereby make the following regulations:-
