THE PRISONERS (RELEASE ON LICENCE)
ORDER No. 21 OF 1991

An Order to provide for the release of prisoner JIMMY MOLI STEPHENS.

IN EXERCISE of the powers conferred by section 30 of the Prisons (Administration) Act [Cap. 20], I, IOLU J ABBIL, Minister of Home Affairs and Minister responsible for Prisons, HEREBY MAKE the following Order :-

RELEASE OF PRISONER ON LICENCE

1. Jimmy Moli Stephens who is currently being held in custody as a prisoner, shall be set free and released from prison on the 20th day of September, 1991 SUBJECT TO THE TERMS AND CONDITIONS set out in sections 2 and 3 of this Order.

TERMS AND CONDITIONS OF RELEASE

2. The following terms and conditions shall apply :-

- (a) Jimmy Moli Stephens shall keep the peace and be of good behaviour for a period commencing on the day of his release being the 20th day of September, 1991 and ending on the 30th day of May, 1997, which period is hereinafter called "the relevant period";
- (b) In the event that Jimmy Moli Stephens should commit a criminal offence during the relevant period, whether or not the offence is of a similar nature as that for which Jimmy Moli Stephens' original prison sentence was ordered by the Court or, the Court before which Jimmy Moli Stephens appears for such new offence orders a prison sentence, Jimmy Moli Stephens shall automatically be recalled and returned to prison.

PROCEDURES RELATING TO VIOLATIONS OF CONDITIONS OF RELEASE, RECALL TO PRISON, ETC.

3. In every case where the provisions of paragraph (b) of section 2 apply, the following procedures shall apply :
 - (a) Where the Minister is satisfied that Jimmy Moli Stephens has violated the terms and conditions set out in section 2 he shall issue a Notice in writing directing that Jimmy Moli Stephens is returned to custody forthwith;
 - (b) A Notice issued by the Minister shall be served on Jimmy Moli Stephens directing him to return to prison at such time and on such day as specified in the Notice;

- (c) Jimmy Moli Stephens when returned to prison in accordance with this section shall be obliged to serve the unexpired term of his original sentence which he would have had to serve if he had not been released in accordance with this Order;
- (d) Jimmy Moli Stephens when returned to prison in accordance with this section is not entitled to have part of his original unexpired term of sentence remitted.

**COMMISSIONER OF POLICE AND SUPERINTENDENT OF PRISONS
TO ENFORCE DIRECTIONS OF THE MINISTER**

4. The Commissioner of Police and the Superintendent of Prisons shall take all lawful measures required or necessary to enforce every Direction or Notice issued by the Minister under this Order.


5. This Order shall come into force on the 20th day of September, 1991.
